Chairman Mr. Bentley called meeting to order at 6:35 P.M. with quorum present 1. SET AGENDA

Mr. Bentley asked that Old Business A. be moved up so that Mr. Dapron could present his information.

5a. CASELLA WASTE MGT. SINGLE STREAM FOR MRF update

Mr. Dapron distributed educational literature on zero sort recycling that had been requested at a previous meeting. A tour of the retrofit underway at the MRF was provided by Mr. Joe Soulia and Mr. Dapron. Q & A was exchanged throughout the tour.

Mr. Dapron mentioned that he had provided Mr. O'Gorman with a copy of the MRF lease with attached amendments. Mr. O'Gorman stated that he hadn't had time to review it. Mr. Nevin asked about the financial cost of processing recyclables. Mr. Dapron said that the numbers wouldn't be ready until the MRF had a chance of running for a month so that the cost of processing could be analyzed. Discussion followed on possible scenarios at the transfer stations that would maximize collection and minimize transport of material.

3. FINANCIAL STATEMENTS OF AUGUST 2011

Mr. O'Gorman stated trash tonnage was more than budgeted but still less than previous years. Market prices for commodities have fluctuated. Mr. O'Gorman provided a managers report that provided more information on the finances. Mr. Taggart moved to accept the financial statements. Mr. Bixby provided the second. Motion passed unanimously.

A. VLCT HEALTH INSURANCE

The thought was raised that the federal health insurance program starting in 2014 creates an uncertainty for many companies.

The following topics were discussed at the recent manager's meeting: Funding for solid waste infrastructure, one topic involved unclaimed deposit monies Increasing the state solid waste tax Bottle bill Landfill Bans

Mr. Barrows suggested that any movement on the bottle bill be postponed until a review of how zero-sort would impact the recycling stream. Mr. Bentley asked how landfill bans and the optimal concept for waste management were related.
