- CALL BOARD MEETING TO ORDER.

- Rutland County Solid Waste Districts' 2021-2025, Solid Waste Implementation Plan (SWIP) Hearing discussion.
 - Mr. Taggart said we will have a SWIP public hearing then the regular BOS meeting tonight. He asked Mr. Shea about the SWIP public meeting process.
 - Mr. Shea confirmed that we will have 2 SWIP open meetings, one tonight and one next month. After we complete the two open meetings, and no changes are approved by the Board, we will present the minutes and Boards wished the State for final approval. If there are no changes then we should be approved, but if there are changes and other recommendations, we will need to restart the SWIP public meeting process again.
 - Mr. Taggart suggest having the SWIP open hearing first next month then go to the regular BOS meeting.

- Mr. Sales presented a PowerPoint presentation on the SWIP plan. Some discussion of a few of the key elements of the plan where elaborated on during and after the presentation.
- Mr. Taggart said there will be an E-board meeting next month to go over job descriptions. Some board members request hard copies of job descriptions mailed to them.
